



Matching food-growers with land-owners in Scarborough

REGISTRATION FORM - GARDEN/LAND-OWNER (or agent)

Before completing this form, please consider the following points:

- You will be allowing someone to ‘adopt’ part (or all) of your garden to grow fruit and vegetables and not for the purposes of keeping any form of livestock (such as hens or bees)
- They must be able to visit your garden/land to tend their crops at times agreed beforehand
- Try to give as long a period of notice as possible if you no longer wish your garden/land to be used but not less than 6 weeks
- The first meeting will be mediated by Growing Opportunities when an agreement will be drawn up between the land owner and the grower

By answering these questions you are helping us to find a food-grower most suited to your garden/land. However, if you are unable to answer any questions please do not worry.

2. What proportion of your garden would like ‘adopted’?
(e.g. “about half” “about a quarter” or “all”)

4. Is there access to water? Please describe.
5. Would you be happy for water butts/compost bins to be installed at no cost to yourself?
6. How did you first hear about Growing Opportunities?
7. Do you have any gardening skills that you would be willing to share with the grower?

9. Are you happy for grassed areas to be turned over to growing vegetables?

- ☘ Pesticides are severely restricted - instead organic growers develop nutrient-rich soil to grow strong healthy crops and encourage wildlife to help control pests and disease
- ☘ Artificial chemical fertilisers are prohibited - instead organic growers develop a healthy, fertile soil by growing and rotating a mixture of crops
